1. General

1.1. Introduction

The International Commission on Holocaust Era Insurance Claims (ICHEIC) was established in October of 1998 by European insurance companies, US insurance regulators, representatives of international Jewish organizations and the State of Israel in order to establish a just process that would expeditiously address the issue of unpaid insurance policies issued to victims of the Holocaust. Soon afterwards it became evident that the information on Holocaust era insurance policies provided to ICHEIC by the member companies might benefit from supplementary research. This fact gave birth to the idea of supplementing the information received from the companies by “external research”, i.e. research in relevant public archives and repositories.

The aim of external research was to locate and register information on Holocaust era life insurance policies and their owners. This resulted in the creation of the ICHEIC research database, which serves a double need: to provide names of Holocaust era insurance policy holders that could be published in order to encourage potential claimants to submit their claims and to provide a body of reference which could be used for verifying and processing incoming claims submitted by the public.

The project started in early 2000 and continued until early 2003. Nevertheless it should be said that this scope of time was not defined at the beginning of the work; rather a period of six months was mentioned which later on was extended from time to time until, as already mentioned, early 2003.

The remaining part of section 1 of this report presents the sources, the process, and the results of the research in general while section 2 describes the research project in all the 15 countries in which it has been conducted, country by country. This is followed by two appendices: appendix A contains detailed statistical data on the project and appendix B lists researched holdings which provided no information on policies.

1.2. The sources

The archival sources, which were used for the research, can be roughly classified into three broad groups:

- **Nazi period registration and confiscation records**

Throughout the Nazi period a gigantic bureaucratic machine dealt with registration and confiscation of assets belonging to Holocaust era victims. This activity resulted in enormous quantities of archival material, which was by far the main source for this research.

- **Post-war schemes for registration of damages and losses**

Many countries affected by WWII introduced, once the war was over, schemes for registration of damages and losses to assets owned by their citizens and residents while in the USA the census of foreign assets was conducted in 1943.

- **Records of insurance companies in public archives**

Although the archives of insurance companies themselves were not accessible in the framework of this research, in some cases their records were located in various public archives and researched.

1.3. The research process

Usually research in a country began with a general survey of its seemingly relevant archival holdings, which would subsequently be used in order to reach a decision on the feasibility of research and establish priorities. Next, the pinpointed holdings would be researched, item by item, in order to locate files/forms which comprise information on Holocaust era life insurance. These would in turn be scanned (or, in a small number of cases, otherwise copied) and later on registered from the scanned images into a specially programmed database with custom-designed registration form. This procedure, although obviously more time-consuming than direct registration from original records in archives, has a number of important advantages which clearly outweigh this shortcoming. First of all, rather than registering documents at a number of archival repositories, consolidating registration at one, central location provides maximal quality control at minimum expense because one supervisor is able to oversee a large number of researchers. Furthermore a well appointed and maintained registration center provides much better working conditions than those which would usually be available in archives, which by itself enhances the quality of work. Another benefit of this procedure is that the scanned images of original documents, which are easily accessible at a central location, are very often essential in order to process incoming claims, verify registration and provide means for identification of claimants.

After a number of trials, which examined various possibilities of scanning, it was found that the most efficient procedure is to have teams of two researchers, one of whom is responsible for scanning and the other for handling the computer. At

the time of scanning records were given provisional descriptions to enable their retrieval before the final registration.

The final registration from the scanned images into the database was then done as a concentrated project at the office of Facts & Files in Berlin, again by researchers working in teams of two. This method of registration further ensured quality control through mutual oversight by both researchers. The scanned images are linked directly to each data set in the research database and can easily be retrieved for additional examination during the claims verification process and/or for legal purposes.

1.4. The results

When the external research was completed, it resulted in the creation of a database of Holocaust era life insurance policies (hereafter: policies) comprising information on 77,518 policies belonging to 55,079 policy holders. Some 16,579 additional people were connected to the policies as beneficiaries and the insured persons. The information on the policies was retrieved from hundreds of archival institutions and repositories in 11 countries: Austria, Bulgaria, The Czech Republic, Germany, Israel, Lithuania, Poland, Slovakia, Switzerland, United States, and the Ukraine. To this end hundreds of thousands of files/forms were researched, some of which were identified as relevant and scanned or otherwise copied and registered. The research in four additional countries (Greece, Hungary, Romania, and the Russian Federation) provided no significant information on policies.

The breakdown of the database into countries of research and into countries of last known residence of policy holders is shown in tables 1 and 2, respectively.

2. Research in various countries

2.1. Germany

The research in German archives and repositories was conducted in two main phases. The first phase was commissioned directly by ICHEIC and executed between 2000 and 2001, and the second phase was commissioned in September 2002 by the German foundation “Remembrance, Responsibility and Future” under an agreement with ICHEIC, and lasted until April 2003.

In February 2002 the German Parliament passed an amendment to the Archives Law, allowing wider access to personal records of victims of Nazi persecution. Files that used to be closed as “tax files” were from then on available for research. Consequently, it became possible to include in phase two of the research records that were previously unavailable to ICHEIC. It can now be said that thanks to the combined research effort of the German Foundation and ICHEIC, all known relevant holdings in German archives have been perused.

The results obtained in Germany exceeded by far all the other countries contributing more than 53% of the entire number of policies. This can be explained by the enormous wealth of archival material created by the Nazi authorities, by excellent cooperation of almost the entire German archival system and by higher number of insurance policies *per capita* than in most other countries. At the same time, it should be mentioned that German sources also revealed information on numerous Austrian, Czech, Polish, Serbian and other policy holders.

All in all, research in Germany contributed information on 41,540 insurance policies belonging to 27,886 policy holders. To this end 33 various archival institutions and repositories were visited and some 123 record groups and collections were researched.

Most of the information on the policies was retrieved from the following holdings (a complete list of German sources which provided information on policies is to be found in appendix A/8).

Bundesarchiv Zwischenarchiv Dahlwitz-Hoppegarten, Berlin

- Record Group (RG) R2107, Oberfinanzdirektion (OFD) Berlin-Brandenburg, Anmeldung Feindlichen Vermögens/High Financial Office, Berlin-Brandenburg, Registration of Enemy Property

This record group comprises declarations on property belonging to the enemies of the Reich submitted by insurance companies and various custodians. Some 10,000 of about 1,000,000 existing files were researched and contributed 11,067 insurance policies.

Bundesarchiv Berlin-Lichterfelde

- RG R8150, Reichsvereinigung der Juden in Deutschland/Reich Association of the Jews in Germany

The holding comprises the so called "Heimeinkaufvertrag", confiscation of property belonging to victims who were deported to Theresienstadt. About 150 files were researched and yielded 178 policies.

- RG R26IV, Generalbevollmächtigter für die Wirtschaft in Serbien/General Plenipotentiary for Economy in Serbia

The holding comprises lists of insurance policies owned by Serbian Jews, which were submitted by the insurance companies to the German occupation authorities. Research of 100 files resulted in 1,888 insurance policies.

- RG DN 1, Ministerium der Finanzen der DDR, Hauptabteilung Ausländisches Vermögen in der SBZ/DDR/Ministry of Finance of the GDR, Department for Foreign Assets in the Soviet Zone and the GDR

This holding, which consists of property declarations, contributed 707 policies.

Oberfinanzdirektion Berlin

- Files of Judenvermögensabgabe

The holding consists of the 1938 Jewish property declarations and the assessments of the special punitive tax for Jews introduced by the Nazis in the wake of the "*Kristallnacht*". More than 20,000 files were researched which yielded 4,388 policies.

- Files of Haupttreuhandstelle (HTO) Ost, Sonderabteilung Altreich/Head Custodian Office East, Special Department Altreich

This special branch of the HTO was responsible, inter alia, for the confiscation of property of Polish citizens who were expelled from Germany in 1938. Some 7,000 researched files contributed 382 policies.

Landesarchiv Berlin/Berlin State Archives

- RG 93-03 Finanzamt Moabit-West

The holding, which consists of about 5,000 cases of property confiscation in the wake of the revoking of German citizenship, contributed 802 policies.

- RG B Rep. 92, Oberfinanzdirektion Berlin-Brandenburg

This huge holding has been transferred to the Brandenburgisches Landeshauptarchiv in Potsdam and given a new notation RG Rep. 36A (II). It is described in the following listing.

Brandenburgisches Landeshauptarchiv, Potsdam/Brandenburg State Archives, Potsdam

- RG Rep. 36A, Rep. 36A (II), OFD Berlin-Brandenburg, Devisenstelle and Vermögensverwertungsstelle and Rep. 36C Finanzämter

The holding comprises about 60,000 individual files, which relate to mortgages, real estate, emigration, individual declarations and confiscation of property. Because of its ongoing transfer from the Berlin State Archives, the holding was

researched in Berlin, in Potsdam and from microfilms available at the Yad Vashem Archives in Jerusalem. Altogether it contributed 4,871 policies.

Staatsarchiv München/Munich State Archives

- RG OFD 307 pp, Finanzämter München und Oberbayern/Tax Offices Munich and Oberbayern

The holding comprises tax records of former racial persecutees and their property declarations. Some 3,200 files were researched which contributed 1,747 policies.

Staatsarchiv der Freien und Hansestadt Hamburg/Hamburg State Archives

- RG 314-15, Oberfinanzpräsident (OFP) Hamburg/High Financial Office Hamburg and two additional Hamburg tax offices

The holding comprises property declarations by German Jews, mostly in emigration files. Some 14,700 files were researched and yielded 3,512 policies.

Hessisches Hauptstaatsarchiv, Wiesbaden/Main State Archives of Hesse, Wiesbaden

- RG Abteilung 519, Landesamt für Vermögenskontrolle und Wiedergutmachung in Hessen/State Office for Property Control and Reparations in Hesse

The holding comprises records of the Devisenstellen Kassel and Frankfurt/Main and of a number of tax offices with some 46,000 personal cases and files on individual declarations of property by German Jews. The holding yielded 4,564 policies.

Niedersächsisches Hauptstaatsarchiv Hannover/Main State Archives of Lower Saxony, Hanover

- RG Hann 210 and Nds 225, Oberfinanzpräsident Hannover and various tax offices

The holding, only very recently located in tax offices, was being catalogued during the research. It comprises records of the OFP in Hannover, the Devisenzweigstelle Braunschweig and a number of tax offices with some 10,000 personal records. It yielded 1,091 policies.

Nordrheinwestfälisches Staatsarchiv Münster/State Archives of North Rhine Westfalia, Munster)

- RG OFD Münster, Oberfinanzpräsident Münster and the tax office Ahaus

The holding, which only very recently became available for research, comprises some 11,000 personal records. It yielded 987 policies.

A list of researched record groups in which no information was found on insurance policies is enclosed in appendix B/1.

2.2. Slovakia

The research in Slovakia made extensive use of forced declarations of Jewish assets, which had to be filled out twice: in 1940 by all Jewish residents and in 1942 by all Jewish families. Almost the entire collection of the 1940 forms has been located in the Slovak National Archives in Bratislava while the 1942 declarations only survived for the residents of Bratislava.

Most of the information on the policies was retrieved from the following holdings (a complete list of Slovak sources, which provided information on policies, is to be found in appendix A/8).

Slovenský národný archív v Bratislave/Slovak National Archives in Bratislava

- RG HÚPV, Hospodárskej úradovne predsedníctva vlády/Governmental Office for Commerce

The holding consists of 180 boxes which contain some 80,000 1940 declarations of Jewish assets arranged by the place of residence. It contributed 9,163 policies.

- RG PR, Policajne riaditeľstvo v Bratislave/Police Headquarters in Bratislava

The holding, which includes 40 boxes of 1942 declarations of Jewish asset from the city of Bratislava only, contributed information on 581 policies.

- RG ÚHÚ, Ústredný hospodársky úrad/Central Property Office

The holding consists of more than 700 boxes of records dealing with the "aryanization" of Jewish firms in Slovakia. The assets of the firms and of their Jewish owners were declared on a special form. Research of a small sample provided 18 policies.

- RG SP, Súkromné poisťovne na Slovensku/Private Insurance in Slovakia

The collection, which includes records of various Slovak inter-war private insurance companies liquidated after the war, provided information on 772 policies.

A list of researched record groups in which no information was found on insurance policies is enclosed in appendix B/8.

2.3. Bulgaria

Research in Bulgaria made extensive usage of a large numbers of archival holdings originating from insurance companies.

Most of the information on the policies was retrieved from the following holdings (a complete list of Bulgarian sources which provided information on policies is to be found in appendix A/8).

Centralen durzhaven archiv Sofia/Central State Archives in Sofia

- RG 302, Durzhaven zastrahovaten institute/State insurance company

The holding, which consists of reports on inspections of private insurance companies and long list of insurance policies of private companies, contributed information on 6,389 policies.

- RG 903, "La Nationale", Sofia/Insurance company "La Nationale", Sofia

The holding, which consists of records of the Bulgarian branch of "La Nationale", provided information on 1,202 policies.

- RG 895, "Vitosha"/Insurance company "Vitosha"

The holding, which consists of records the Bulgarian insurance company "Vitosha", provided information on 1,175 policies.

- RG 905, Assicurazioni Generali, Sofia

The holding consists of records of the Bulgarian branch of Assicurazioni Generali. It mostly includes correspondence regarding the transfer of insurance policies from the insurance stock in Yugoslavia and Greece to the Bulgarian stock. These policies originated in Macedonia (Yugoslavia) and Tracia (Greece),

territories which were occupied by Bulgaria during WWII. It provided information on 1,026 policies.

- RG 904, Riunione Adriatica, Sofia

The holding, which consists of records of the Bulgarian branch of Riunione Adriatica, contributed information on 63 policies.

- RG 212 - Durzhaven nadzor vurhu chastnite zastrahovatelni predpepriyatiya/State Inspection of Private Insurance Companies

The holding, which consists of reports on inspections of private insurance companies before 1944, contributed information on 241 policies.

- RG 477, Nadzor vurhu imushtestvata na podanicite na nepriyatelski durzhavi/State Administration of Enemy Property)

The holding consists of more than 4,000 files concerning the administration of enemy property. Due to access restrictions only a part of the holding has been researched and it contributed 114 policies.

- RG 132, Bulgarska Nacionalna Banka/Bulgarian National Bank

The holding, which contains of correspondence with the State Insurance Institute, provided information on 13 policies.

- RG 190, Komisarstvo po evrejskite raboti/Commissariat for Jewish Affairs

The holding consists of approximately 14,500 records with regard to the auctions of Jewish property and declarations of property. It provided information on 12 policies.

2.4. The Czech Republic

Thanks to the most supportive attitude of the Czech authorities it was possible not only to research records kept in public archives but also in governmental repositories throughout the Republic. All in all some 2,000 boxes containing 30,000 files in 10 locations were researched and contributed 7,384 insurance policies belonging to 4,192 policy holders.

Most of the information on the policies was retrieved from the following holdings (a complete list of Czech sources which provided information on policies is to be found in appendix A/8).

Ministerstvo financí Česká republika, depo Kladno/Czech Ministry of Finance,
Kladno Repository

- RG Česka banka Union/Böhmische Union Bank (BUB)

The holding comprises the complete correspondence of the bank's headquarters from 1937 until its liquidation in about 1956. Included in these records are thousands of letters to the German occupation authorities and other bodies regarding the confiscation of Jewish assets. The bank was often appointed as a trustee for Jewish assets and managed special accounts and depots for the office in charge of the confiscation. Life insurance policies deposited at the bank played an important role within the correspondence. The holding contributed 2,238 policies of 1,565 policy holders.

Státní ústřední archiv v Praze/Czech Central State Archive in Prague

- RG NSMPO, Národní správa majetkových podstat/National Administration of Property

The holding consists of about 700 boxes of original records coming from various German occupation offices, comprising correspondence regarding the "aryanization" of Jewish companies and the confiscation of Jewish assets in the "Protectorate of Bohemia and Moravia". It contributed information on 1,047 policies.

- RG MPSP, Ministerstvo práce a sociální péče/Czech Ministry for Labour and Social Welfare

The records of the post war Office for Restitution of Jewish Property (within the ministry) were researched and provided information on 383 policies.

- RG MF, Ministerstvo financí, 1918-1949/Czech Ministry of Finance

Within this holding only a small number of relevant records survived. They consist of 4 big ledgers registering incoming confiscated Jewish property. It provided information on 679 policies.

- RG ÚŘP, Úřad říšského protektora/Reichsprotektor in Böhmen und Mähren/
Protectorate of Bohemia and Moravia

This record group is a collection of surviving records of the central German occupation authorities of the Protectorate. Relevant records were applications for emigration and records concerning "aryanization" of Jewish firms and confiscation of Jewish property. It provided information on 577 policies.

Moravský zemský archiv v Brně/Moravian Regional Archives in Brno

- RG D 25, Zollfahndungszweigstelle Brünn/Office for Customs Investigations in Brno)

The holding comprises 10,000 files on customs investigations against Jews who tried to leave the country. It provided information on 1,853 policies.

- RG B 254, Oberlandrat Brünn/[German] District Administration of Brno

The record group includes records on the “aryanization” of Jewish firms in the city and in the district of Brno. The assets of the firms and of their Jewish owners were declared on a special form printed in German and Czech. The holding contributed information on 175 policies.

- RG G 427, Treuhand und Revisionsgesellschaft m.b.H Prag, Filiale Brünn und Ostrau

The Treuhand und Revisionsgesellschaft was a German accounting and audit firm which was commissioned to manage Jewish firms and assets as a trustee. The record group, which comprises files of its subdivisions in Brno and Ostrava, contributed 257 policies.

- RG H 1029, Böhmisches Union Bank in Brünn/Bohemian Union Bank, Subdivision in Brno

The records, which include correspondence on the handling and confiscation of Jewish assets, provided information on 244 policies.

Státní okresní archiv Olomouc – Zemský archiv v Opave pobočka Olomouc/
State District Archive in Olomouc - Regional Archives in Opava, division Olomouc

- RG OLR Olomouc – Oberlandrat Olmütz/German district administration of Olomouc

The record group includes records on the “aryanization” of Jewish firms in the city and district of Olomouc. The assets of the firms and the Jewish owners were declared on a special form printed in German and Czech. The holding provided information on 28 policies.

- RG FP Olomouc – Finanční Prokuratura Olomouc/[Czech] Finance Administration of Olomouc)

The record group, which includes restitution claims submitted to the State Foundation for National Renewal, contains information on one policy.

Státní oblastní archiv v Zámruku/State Regional Archives in Zámruk

- RG VFZ Pce – Jüdischer Auswanderungsfonds Pardubitz/Fund for Jewish Emigration in Pardubitz

The record group, which includes registration forms of Jewish property and post-war claims for restitution, provided information on 8 policies.

A list of researched record groups in which no information was found on insurance policies is enclosed in appendix B/7.

2.5. The USA

Extensive research in the US located more than 5,800 policies in the following holdings:

The National Archives of the United States, College Park, MD

- RG 265, Records of the Office of Foreign Assets Control

The holding comprises returns of the 1943 census of property in foreign countries held by US residents. More than 100,000 returns were researched in order to locate those submitted by Jewish refugees from Europe, which contributed information on 4,437 insurance policies.

US Holocaust Memorial Museum, Washington, DC

RG 1999A.0178, Ministarstvo Državne Riznice. Ponova. Ured za Podržavljeni Imetak, Serija Prijava "P"/ [Croatian] Ministry of the State Treasury, Office for Nationalized Property, Series of "P" Reports

The holding comprises 1942 Croatian registration forms of Jewish property which contributed 1,398 policies.

A complete list of US sources which provided information on policies is to be found in appendix A/8 and a list of researched record groups in which no information was found on policies in appendix B/2.

2.6. Poland

The research project in Poland took a two-fold approach: cooperation with the Polish State archives and with the Polish State Insurance Institute (PZU).

The research in Polish state archives was executed in the framework of an agreement with the Head Office of State Archives according to which the research was done by the staff of relevant archival institutions. All in all hundreds of record groups in 27 archival institutions were researched but the number of located Holocaust era policies is relatively very small. Furthermore the located policies do not really refer to residents of Poland in its inter-war borders but to German, Austrian and other residents who used to live in the East German provinces or were deported to Poland by the Nazis. This can be, it seems, explained by two phenomena: the number of life insurance policies per capita in Poland was much smaller than in central Europe and many records of the German occupation regime, which was involved in the registration and confiscation of Jewish assets were destroyed at the end of the war.

Most of the information on policies was retrieved from the following holdings (see also paragraph 2.7.).

Archiwum Państwowe w Łodzi/The State Archives in Łódź

- RG Przełożony Starszeństwa Żydów w Getcie Łódzkim/Der Aelteste der Juden in Litzmannstadt-Getto/The Elder of Jews in the Łódź Ghetto

The holding comprises declarations of Jewish assets submitted by the Elder's office to the Nazi authorities. Ten files were researched which contributed 25 insurance policies mainly belonging to Vienna Jews deported to the Łódź Ghetto.

Archiwum Państwowe we Wrocławiu/The State Archives in Wrocław

- RG 246, Urząd Skarbowy Prowincji Dolnośląskiej we Wrocławiu/
Oberfinanzpräsident Niederschlesien – Breslau/High Financial Office for Lower Silesia in Breslau

The holding comprises some 3,800 personal files on Jewish property which contributed 150 policies.

Archiwum Państwowe w Poznaniu/State Archives in Poznań

- RG 759, Urząd powierniczy w Poznaniu/Treuhandstelle Posen/Custodian Office in Poznań

Some 185 files were researched and contributed 8 policies.

A complete list of Polish sources which provided information on policies is to be found in appendix A/8 and a list of researched record groups in which no information was found on policies in appendix B/3.

In September 2001 an agreement was signed with the PZU, according to which the PZU forwarded to ICHEIC a list of post-war claimants to inter-war insurance policies by Generali and RAS who were not compensated, either because they resided outside of Poland or because they were unable to submit the required original documentation on their policies. The list originated from a compensation scheme introduced in the mid-1950s under which the holders of life insurance policies issued by the companies, which were nationalized by the PZU, could submit claims to their monies. All in all, this source contributed information on 1,287 inter-war Polish insurance policies.

2.7. The Ukraine

The archives of the Lvov (today Lviv) branch of the Riunione Adriatica di Securta (RAS) insurance company were located in the Central State Historical Archives (TsDIA-L) in Lviv and microfilmed. Its 134 files contributed information on some 678 policies issued in the 1930s in the then Polish district of East Galicia.

2.8. Israel

Extensive research in Israel failed to locate the archives of the Israeli Registrar of Foreign Claims, which would be of much importance for the project. It seems that this holding has been disposed of. Otherwise the following were the most important Israeli sources of information (a complete list of Israeli sources which provided information on policies is to be found in appendix A/8).

Israel State Archives, Jerusalem

- RG 91, [Palestine Government] Custodian of Enemy Property

Information on some 105 policies was derived from 16 boxes of claims submitted to the custodian by Jewish residents of Palestine in the years 1946-1947.

- RG 93/7, Israel Mission in Czechoslovakia

The holding comprises claims to assets left in Czechoslovakia which were submitted in the second half of the 1940s to the Jewish National Fund by Israeli residents. It contributed 112 life insurance policies.

Yad Vashem Archives, Jerusalem

- RG OFP Berlin/High Financial Office in Berlin

The holding comprises financial files of Jewish residents of Berlin microfilmed in Brandenburgisches Landeshauptarchiv in Potsdam. It contributed 942 policies (see also paragraph 2.1. under Brandenburgisches Landeshauptarchiv, Potsdam).

A list of researched record groups in which no information was found on policies is enclosed in appendix B/4.

2.9. Austria

Most of the research in Austria has not been done in the framework of this project and will not be described here. Otherwise information on 138 insurance policies has been derived from research in the Bundesministerium für Finanzen (Federal Ministry of Finance) in Vienna.

2.10. Lithuania

Research in the records of the Lietuvos Respublika Valstybės Draudimo Įstaiga (Lithuanian State Insurance Company [RG R 750 & 1282]) kept at the Lietuvos Centrinis Valstybės Archyvas (Lithuanian Central State Archives) in Vilnius resulted in information on 109 policies.

2.11. Switzerland

Archives of the Meldestelle für Vermögen verschwundener Ausländer (Claims Registry for Assets of Foreigners who Disappeared) held at the Bundesarchiv in Bern were researched and contributed 67 policies. The Meldestelle was responsible for processing the 1964 claims to heirless property in Switzerland.

2.12. Greece

The survey of Greek archives, which was commissioned by the ICHEIC and executed by an Israeli scholar, was submitted but did not indicate holdings which would justify additional research (see also appendix B/2).

2.13. Hungary

Following an initial survey of Hungarian archives, an in-depth research project was commissioned and executed by a local scholar. No less than 100 record groups and collections have been researched, including archives of insurance companies, commercial banks, the Hungarian National Bank, the Center of Financial Institutions, Ministry of Finance, and Ministry of Foreign Affairs but no significant information on policies has been located. The list of researched record groups is enclosed in appendix B/5.

It should also be mentioned that a collection of microfilms containing Holocaust era Hungarian records on Jewish assets, which has been researched at the Yad Vashem Archives in Jerusalem, yielded similar results.

2.14. Romania

The survey of Romanian archives, which was commissioned by the ICHEIC and executed by an Israeli scholar, did not indicate holdings which would contain information on insurance policies.

2.15. The Russian Federation

Selected files of the Nazi Ministry of Economy (Reichswirtschaftsministerium) and other Holocaust era German organizations kept at the Russian Military Archives in Moscow were researched and copies of the most relevant records were ordered. Although they did not contribute information on life insurance policies, they contain important data on Jewish property insurance problems in the wake of the "*Kristallnacht*".

A list of researched record groups in which no information was found on policies is enclosed in appendix B/6.

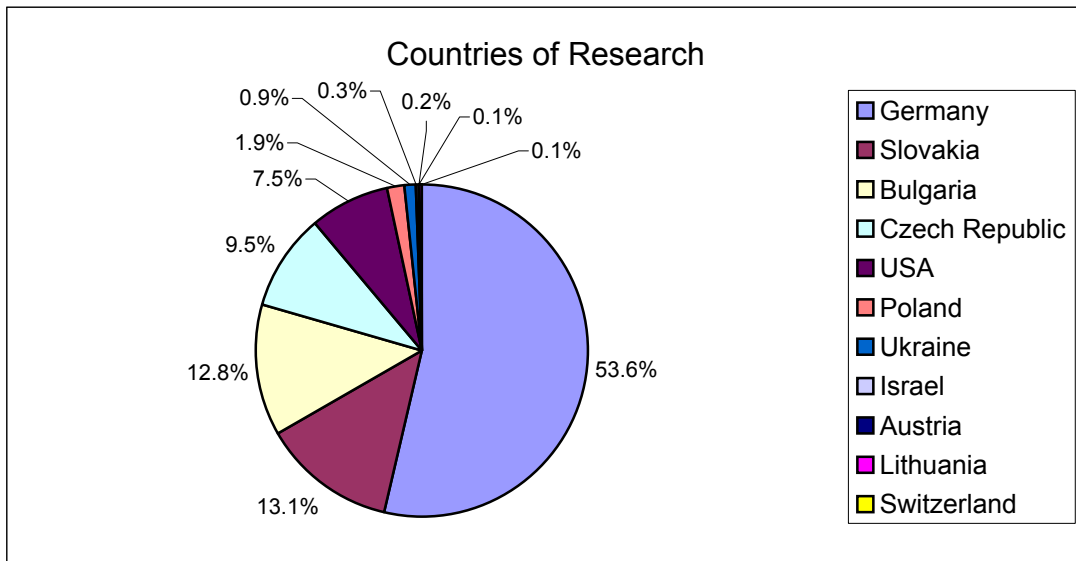

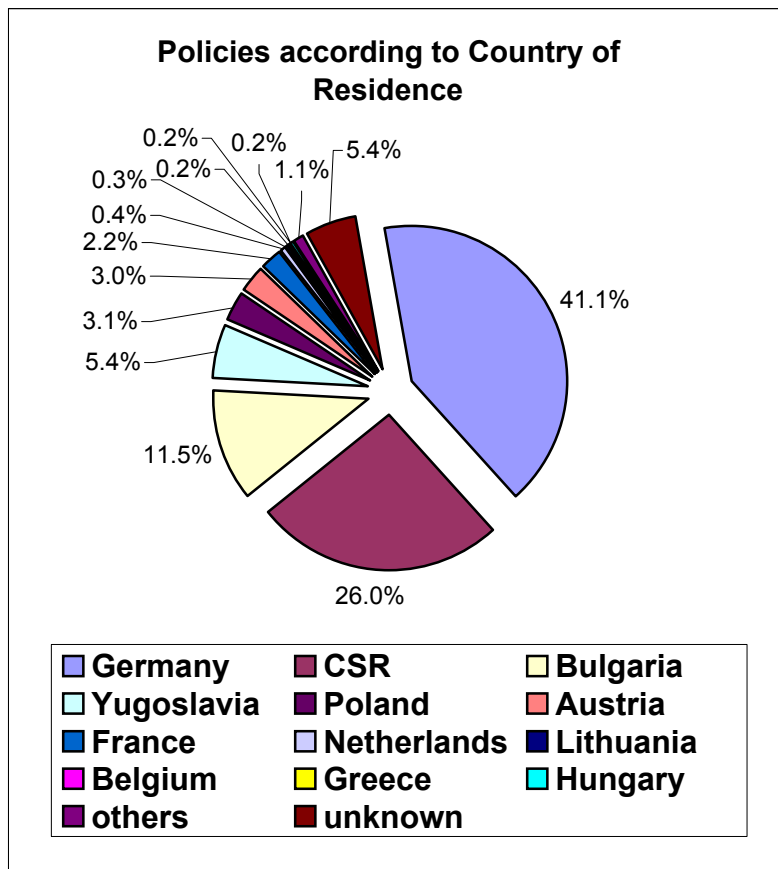

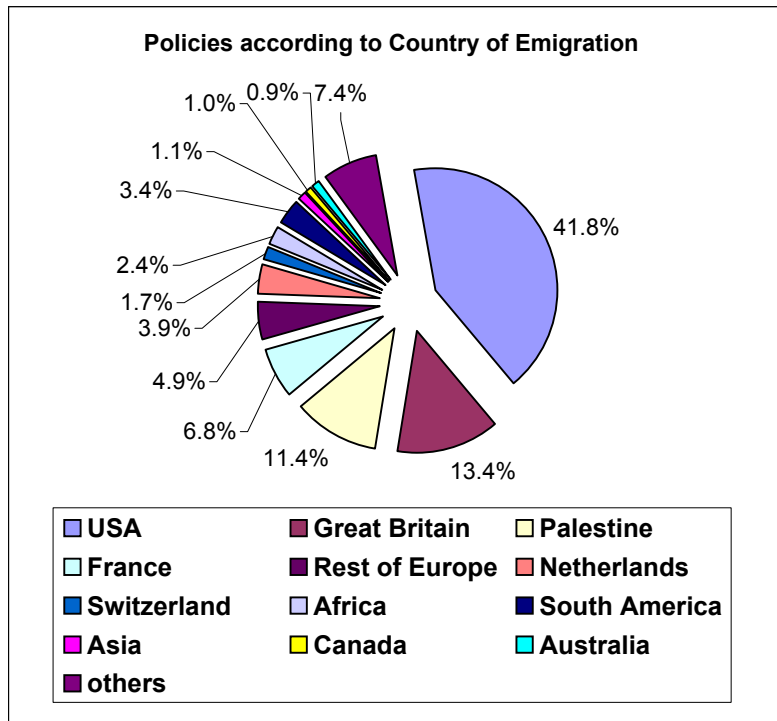
